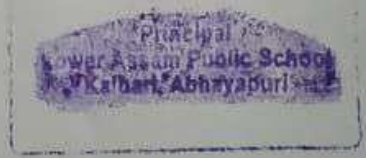



I have been directed to inform you that, consequent upon your provisional selection in the Central Armed Police Forces (CAPFs), NIA & SSF and Rifleman (GD) in Assam Rifles (AR) Examination- 2018, organized by Staff Selection Commission (SSC), for the recruitment to the post of Constable (General Duty), you have been allocated to Border Security Force (BSF) by the SSC. A provisional offer of appointment for the post of Constable Mahila (GD) in BSF in pay scale Rs.21700-69100, is hereby proposed, on following conditions:-

Your provisional appointment to the above post will be subject to following terms and conditions:-

So far as pension is concerned you will be entitled the pensionary benefits as per new restructured 'DEFINED CONTRIBUTORY PENSION SYSTEM' applicable for the new entrants to the Central Govt. service from Jan, 2004. Therefore, you would make monthly contribution of @ 10% of the Basic pay and DA towards the new pension system from the date of appointment.

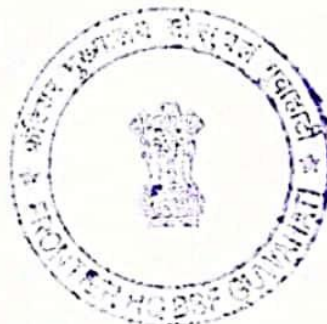


