1. मुझे आपको यह सूचित करने का निर्देश हुआ है कि कर्मचारी चयन आयोग (एसएससी) द्वारा कांस्टेबल (सामान्य ड्यूटी) पद की भर्ती के लिए आयोजित केंद्रीय सशस्त्र पुलिस बलों (सीएपीएफ), एनआईए, एसएसएफ और असम राइफल्स में राइफलमैन (एआर) (जीडी) परीक्षा- 2021 में आप अस्थायी (प्रोविजिनल) चयनित होने तथा कर्मचारी चयन आयोग (एसएससी) द्वारा आपको सीमा सुरक्षा बल आवंटित करने के परिणामस्वरूप आपको सीमा सुरक्षा बल में आरक्षक (सामान्य ड्यूटी) के पद पर वेतनमान 21700-69100 पर अस्थायी (प्रोविजिनल) नियुक्ति का प्रस्ताव निम्नलिखित नियमों एवं शर्तों पर दिया जाता है:-

I have been directed to inform you that, consequent upon your provisional selection in the Central Armed Police Forces (CAPFs), NIA & SSF and Rifleman (GD) in Assam Rifles (AR) Examination- 2021, organized by Staff Selection Commission (SSC), for the recruitment to the post of Constable (General Duty), you have been allocated to Border Security Force (BSF) by the SSC. A provisional offer of appointment for the post of Constable (GD) in BSF in pay scale Rs.21700-69100, is hereby proposed, on following conditions:-

2. उपरोक्त पद पर आपकी अस्थायी नियुक्ति निम्नलिखित नियमों और शर्तों के अधीन होगी:-

Your provisional appointment to the above post will be subject to following terms and conditions:-

(क) आप समय-समय पर यथासंशोधित सीमा सुरक्षा बल अधिनियम-1968 तथा सीमा सुरक्षा बल नियम 1969 और बल के अन्य सदस्यों पर लागू केन्द्र सरकार के अन्य नियमों एवं अधिनियमों से शासित होंगे। जहां तक पेंशन का मामला है, आप जनवरी-2004 से निर्धारित अनुबंध केन्द्रीय सरकार की सेवा के नए प्रवेशकों के लिए लागू नई पुर्नगठन अंशदायी पेंशन योजना के लाभ के हकदार होंगे। नई पेंशन प्रणाली के तहत नियुक्ति की तारीख से आप मूल वेतन तथा डी०ए० का 10 प्रतिशत प्रतिमाह योगदान करेंगे।

You will be governed by the provisions of BSF Act-1968 and BSF Rules-1969 as amended from time to time and other Central Government Orders, Rules and Regulations as applicable to other member of the Force. So far as pension is concerned you will be entitled the pensionary benefits as per new restructured 'DEFINED CONTRIBUTORY PENSION SYSTEM' applicable for the new entrants to the Central Govt. service from Jan, 2004. Therefore, you would make monthly contribution of @ 10% of the Basic pay and DA towards the new pension system from the date of appointment.

Initially, you will be on probation for a period of two years, which may not be extended for more than a duration of one year on exceptional reasons only. During the period of probation, if the appointing authority considers that you are not likely to become an efficient member of the Force due to any reason, your service can be terminated without assigning any reason or without any advance notice.

In addition to pay and allowances as admissible under Rules, you will be entitled for free accommodation, free uniform and ration money allowance etc as admissible from time to time.

1. This appointment is issued against existing vacancy with concurrence of the Finance (SIU) Department U/O dated 03/08/2021, communicated vide Govt. letter No. AEE.135/2021/24 Dated 16/09/2021.

2. The appointee will have to furnish an undertaking along with the joining report as prescribed in the Finance (Budget) Department letter No. BW-3/2003/Pt-II/1 dated 25/01/2005 for "New Pension Rules". The content of the undertaking is as follows:

"I understand and accept that Govt. servant joining the service of the State Govt. on or after 1st February, 2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and order issued there under from time to time and that my pension and other retirement benefits will be governed by a set of New Pension Rules which are in line with the Contributory Pension Schemes of Govt. of India".

- iv. The Appointing Authority may discharge you from service at any time during the period of probation, if in their opinion, your work or conduct during this period is considered unsatisfactory, or shows that you are not fit for permanent appointment.
- v. You will be considered for confirmation in service on your successful completion of probation and if you are found fit in every respect for confirmation.
- vi.
